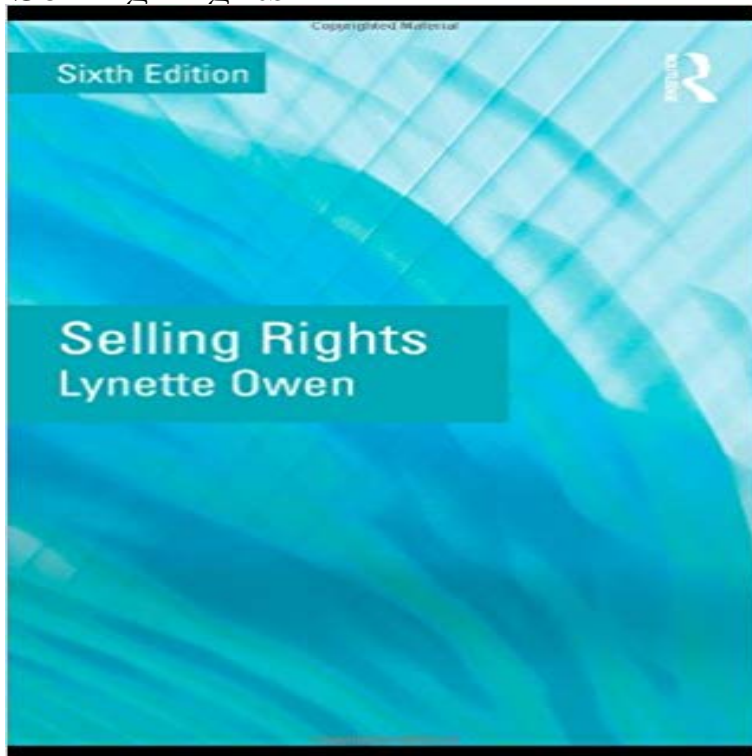


Selling Rights
